- 2. Ministry Support: We request that TERI obtain support from the Ministry of Environment, Forest and Climate Change (MoEFCC) and the Ministry of Education (MoE) for GO4YOUTH. Their collaboration would enhance the reach and impact of the Olympiad across educational institutions.

- g. Banner of cloth displaying all the logos as well as standees etc shall be prominently displayed during the event.
- h. submission of a report on the level of participation and submission of proof of compliance of the aforesaid conditions
- i. 2 Minute Video in English on LiFE shall be played at the start of the event
- j. The report of awareness generation about LiFE through creatives/Selfies/Video film etc together with the high resolution pictures be submitted within 3 days of the close of the event.
- k. The organizations will mandatorily carry out plantation#एक_पेड़_माँ_के_नाम #Plant4Mother and upload 5 pics and/or 3 video clips of up to 45 second duration on MeriLiFE portal (https://merilife.nic.in/) and also provide the same to this Division on the mail ID *mediamoef23@gmail.com* within 1-2 days after the event is over. The video clip on # एक_पेड़_माँ_के_नाम shall also be mandatorily screened along with that on Mission LiFE.
- 2. It may be ensured that the Logo is not used for any commercial purpose. It is requested to submit a report on the level of participation and proof of compliance.
